Terms & Conditions



Thank you for choosing French Meadow for your catering needs. The following terms help us ensure a smooth and delicious experience for every order.

I Order & Confirmation

All catering orders must be submitted in writing and confirmed by a French Meadow team member. Submission of an inquiry form or verbal request does not constitute a confirmed order. An order is considered confirmed only upon receipt of written confirmation from French Meadow.

II Notice & Lead Time

Catering orders require a minimum of 48 hours advance notice. Orders placed with less notice are subject to availability and may not be accommodated. French Meadow reserves the right to decline orders that cannot be fulfilled to our quality standards within the requested timeframe.

III Minimums & Pricing

All catering orders are subject to a minimum order amount as specified at the time of booking. Pricing is based on current menu rates and is subject to change. Final pricing will be confirmed in writing prior to order fulfillment.

IV Payment

Full payment is due prior to delivery or pickup unless otherwise agreed upon in writing. French Meadow accepts credit card, check, or other approved payment methods. A credit card on file may be required to confirm a catering order.

V Right to Modify Terms & Conditions



French Meadow reserves the right to amend, modify, or update these Terms & Conditions at any time. Any revised Terms & Conditions shall become effective upon written notice to the client/host. They shall apply to all future bookings and, where reasonably necessary for operational, legal, safety, or regulatory reasons, to existing bookings.

VI Delivery

French Meadow offers drop-off catering only. Delivery does not include setup, staffing, or service. Delivery times are estimates and may vary due to traffic or other circumstances outside our control. A delivery fee applies and will be confirmed at the time of booking.

VII Dietary & Allergy Requirements

It is the client/host's responsibility to disclose all allergies and dietary restrictions at the time the order is placed. French Meadow will make reasonable accommodations; however, we cannot guarantee a completely allergen-free environment. Failure to disclose known allergies releases French Meadow from related liability.

VIII Service & Administrative Charges

A 20% non-gratuity service charge is applied to all food, beverages, and services — this charge is subject to Minnesota state sales tax and is not distributed as a tip. A 10% administrative charge applies to all outside services arranged by French Meadow on behalf of the client, also subject to Minnesota state sales tax.

IX Cancellation

Cancellations must be submitted in writing to events@frenchmeadowcafe.com. Cancellations made 60 or more days before the scheduled delivery incur a 2% cancellation fee. Cancellations made within 14 days of the scheduled delivery result in the full order amount becoming immediately due.
