1) HOW TO ENTER: Go to your local Islands Restaurants store and use your phone or other electronic device to scan the QR code at your table. During the Promotion Period, visit any participating Islands Restaurants location. Locate the QR code on your table. Using your smartphone or compatible electronic device:

- Open your camera or QR scanning app.
- Point it at the QR code.
- Tap the notification that appears to be redirected to the Sweepstakes landing page.
- Complete the entry form by submitting your full name, email address, phone number, and restaurant location of entry.
- Each Entrant may enter one (1) time per day during the Promotion Period via this method.

Device Requirements:

- Entrants must have a smartphone or device with an internet connection and a functional camera.
- The device must support QR code scanning (standard in iOS 11+, Android 9+).
- Devices must have browser access (Chrome, Safari, etc.).
