This summer, Menya Daruma is holding a sweepstakes to give away a vacation trip to Japan. We are holding a drawing for one trip to Japan which includes (1) roundtrip airfare for two to Tokyo, Japan (up to \$2,500), and (2) \$1,500 towards travel expenses (the "Travel Expense Check"). The winner and their partner are free to explore Tokyo and the surrounding areas and encouraged to eat at the many ramen shops found across Japan.

Eligibility: The Menya Daruma Tokyo Trip Giveaway (the "Giveaway") is a sweepstakes open to all persons aged 21 or older who are residents of the United States. The Giveaway is not open to anyone who is not a resident of the United States. Participants must have a valid passport and email address. Employees of the Sponsor and its affiliates, employees of advertising agencies, their immediate families (spouse and parents, children and siblings, and their respective spouses) and individuals living in the same households of such employees, are ineligible. Any eligible individual participating in the Giveaway will be identified as a "Participant" in these rules.

All times are Eastern Daylight Time. Sponsor's computer is the official time-keeping device for the Giveaway.

- 2. To Enter: No purchase is necessary to enter. To enter, Participants have two options to submit an Entry to the eligible Participant pool.
- 3. Menya Daruma will post one (1) official Tokyo Trip Giveaway announcement to their official Instagram page (@menyadaruma) during the Sweepstakes Period. Eligible Instagram users must: (i) follow the Menya Daruma Instagram account, (ii) 'like' the Announcement Post,

and (iii) tag three (3) additional Instagram users on such Announcement Post in the comments section. Following the aforementioned three steps will entitle that Instagram user to one (1) entry to the Participant pool.

4. Persons can also gain additional entries to the Participant pool by dining at Menya Daruma or ordering carryout from www.menyanoodles.com during the Sweepstakes Period. All persons who submit an order over \$20 during the Sweepstakes Period using the Toast QR ordering system (dine-in orders) or Toast link (carryout orders) from Menya Daruma's website (www.menyanoodles.com) will qualify as one (1) entry to the Participant pool. There are no maximum entries per eligible participants during the Sweepstakes Period. Orders placed through third party delivery services are not eligible for an entry hereunder.

Entries must be received by 11:59 p.m. EST on the applicable Sweepstakes Close date. Any attempt by any person to obtain unauthorized entries or render those entries ineligible and disqualified. Participation must be by the Participant. Participants are required to provide truthful information, and Sponsor will reject any entry that it discovers to be false, fraudulent, or improperly made. Sponsor will disqualify any entry from individuals who do not meet the eligibility requirements.

- 5. Drawing: Sponsor will hold a random drawing for the Giveaway on the drawing date identified above. A random drawing from all eligible entries received will be conducted by Sponsor for the Giveaway. There will be one (1) potential winner per Giveaway, and the winner will be notified within five (5) business days after the random drawing takes place. Odds of winning depend on the total number of eligible entries received. Participants need not be present to win. The potential winner is subject to eligibility verification by Sponsor, whose decisions are final and binding. A Participant is not a winner of any prize, even if notified of being a winner, unless and until the Participant's eligibility has been verified.
- 6. Prizes: There will be one prize for the Giveaway. The winner of the Giveaway is responsible for any airfare costs in excess of \$2,500 and any other costs in excess of the \$1,500 Travel Expense Check, which is payable to winner in the form of a certified check delivered via FedEx or UPS to the address provided by winner. Any transportation to and from the airport, meals, upgrades, excursions, taxes, gratuities, and other charges are the sole responsibility of the winner. The winner is responsible for providing Sponsor will all information necessary for Sponsor to book travel on winner's behalf within six (6) months of winning the Giveaway, with such travel occurring no later than March 30, 2026. Dates of travel are based on availability at time of booking, and travel restrictions may apply. obtaining all required travel documents. If the travel guest is a minor, winner must be their parent/guardian, or be accompanied by their parent/guardian.

- 7. To Claim Prize: Winners will be notified via email and/or phone and will be required to complete and sign an Affidavit of Eligibility, Liability Release, Publicity Release, and IRS Form W-9 (collectively, the "Required Documentation"). Winner must claim the prize and return the signed Required Documentation within thirty (30) days of notification. The potential winner will be disqualified and an alternate winner will be selected by random drawing from among the remaining eligible entries in the following circumstances: the potential winner cannot be contacted using the information provided or fails to respond to Sponsor's attempt to notify them of selection within fourteen (14) days; any notification is returned as undeliverable or yields an error of undeliverable type or "bounce back" email (regardless of whether the message is ultimately delivered to the recipient); Sponsor is unable to verify potential winner's eligibility; potential winner fails to sign and return the Required Documentation within the required time period or fails to comply with these Official Rules; a potential winner is unable or unwilling to accept the prize as stated; or the potential winner cannot be verified as eligible for any other reason.
