

OFFICIAL RULES FOR THE HULI HULI TRIP TO HAWAII GIVEAWAY

1. Eligibility

Purchase Entry: Purchase (1) qualifying Mahana Passport bowl at participating Mahana Fresh locations during the Giveaway period. Each qualifying purchase earns (1) Mahana Passport stamp. Once a Mahana Passport is complete, the guest may submit it for one (1) Giveaway entry.

Mail-In Entry: Send a postcard with your full name, address, phone number, and email address to 7045 Gateway Court, Manassas, VA 20109 with the subject line “Trip to Hawaii Giveaway.” Mail-in entries must be postmarked by April 8th, 2026 and received by April 13th, 2026.
